d) Periodical maintenance and care should be taken to maintain all fire

e) Mock drill has to be conducted at regular intervals in consultation with the Divisional Officer, Fire and Rescue Services, Chennai City Central Division at Kilpauk.

f) The classrooms should always be in the ground floor upto

standards.
