- f) To invest the funds of the Trust not immediately required for the purpose of the Trust in such manner as they may deem fit.
- g) To raise monies from the public by organising benefit performances, collection of subscriptions and donations, bringing out publications and in other ways.
- h) To institute, prosecute and defend all suits, legal and other proceedings in the name of the Managing Trustee.
- i) To appear before Courts, Tribunals, Government, Tax and other public authorities.

V. POWERS OF THE BOARD OF TRUSTEES
